2024 FROZEN SEMEN CONTRACT

This document is an arrangement between *Nebraska Equine Veterinary Clinic* and a mare owner defining the charges for breeding a mare with frozen semen. A single breeding fee (Chute Fee) of \$780 per mare that includes all heat cycles for the breeding season of 2024. This charge applies only to mares that are brought to the clinic for breeding. A mare boarding charge of \$36.16 will be charged daily.

This single charge will include all rectal palpations, all reproductive ultrasound exams, all artificial inseminations, the storage, and handling of frozen semen. Ultrasound exams for pregnancy diagnosis at 14 to 18 days of pregnancy and again at 30 to 35 days of pregnancy will be included but additional follow-up pregnancy exams or ultrasound exams are not included and will be charged separately.

This single charge **will not include** any additional veterinary procedures that may be performed based on the needs of an individual mare. An abbreviated list of such procedures that would require additional fees* is as follows:

- 1) Uterine Biopsy
- 2) Uterine Culture with Antibiotic Sensitivity
- 3) Hormone therapy to time breeding and/or ovulation
- 4) Uterine flush
- 5) Uterine infusion/treatment
- 6) Caslick procedure
- 7) Twin reduction
- 8) Hormone analysis (Progesterone level)
- 9) Sedation
- 10) Other Medications as needed

The fee for storage of frozen semen while the mare is under contract is included in this contract. A storage fee will be charged monthly for frozen semen remaining at Nebraska Equine Veterinary Clinic beginning August 1 of the current breeding season or upon dissolution of this contract. The Frozen Semen Storage Contract is separate from this contract and must be completed before the mare is discharged from the clinic if there are any remaining frozen semen doses at Nebraska Equine Veterinary Clinic.

The mare must be **current on all vaccinations** (Eastern and Western Encephalitis, Rhino, Influenza, Tetanus, Rabies and West Nile) prior to being checked into the clinic. If not, these will be administered at check in at an additional **charge of \$121.13**. If the mare is coming from a farm where an active illness is present, the mareowner must inform the clinic prior to the mare being checked in.

The return of the semen container used for semen transport and the expenses associated with frozen semen storage will be the responsibility of the mare owner. If the breeder wishes the clinic to return the semen shipping container a fee will be charged for shipping and handling.

Financial policy regarding payment schedule: You may begin this contract at any time during the 2024 breeding season, but it **will not be retro-active** on any reproductive work done prior to the contract. The **\$780.00 breeding fee is due at the time the contract is signed and immediately goes into effect.** The

remainder of the bill (mare boarding, additional treatments, and shipping expenses) is due at the time the mare is released from the clinic to go home, unless previous arrangements have been made between the owner and the veterinarian or office manager.
